OVER HALF OF CALIFORNIA'S PRISONS ARE VULNERABLE TO CLIMATE DISASTER

According to forthcoming research, *Hidden Hazards: The Impacts of Climate Change on Incarcerated People in California State Prisons*, done by the Ella Baker Center for Human Rights in conjunction with UCLA's Luskin School of Public Affairs, eighteen of California's thirty-three prisons are vulnerable to one or more climate hazards.

California must continue to pass legislation that leads to significant population reduction, and close state prisons. California must add 'vulnerability to climate hazards' as criteria for selecting prisons for closure.
